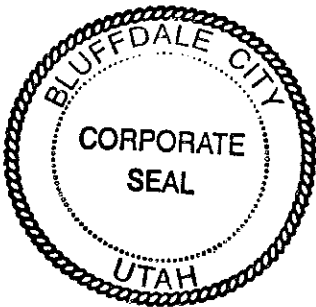

ORDINANCE NO. 2006-01

AN ORDINANCE ESTABLISHING THE TIME AND PLACE OF THE GOVERNING BODY, PLANNING COMMISSION AND BOARD OF ADJUSTMENT MEETINGS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLUFFDALE AS FOLLOWS:


Section 1. TIME AND PLACE OF GOVERNING BODY MEETINGS: The governing body of the City of Bluffdale (City Council and Mayor) shall hold two regular meetings. One on the second Tuesday of each month and one on the fourth Tuesday of each month. The meetings shall be held at Bluffdale City Hall 14175 South Redwood Road, Bluffdale, Utah, which meetings shall begin promptly at 6:30 p.m. If the meeting date is a legal holiday, then the meeting is held at the same time and place above-described on the next following day which is not a legal holiday, Saturday or Sunday.

Section 2. TIME AND PLACE OF PLANNING COMMISSION MEETINGS: The Bluffdale City Planning Commission shall hold one regular meeting on the first Tuesday of each month and one meeting on the third Tuesday of each month. The meetings shall be held at Bluffdale City Hall 14175 South Redwood Road, Bluffdale, Utah, which meetings shall begin promptly at 7:00 p.m. If the meeting date is a legal holiday, then the meeting is held at the same time and place above-described on the next following day which is not a legal holiday, Saturday or Sunday.


Section 3. TIME AND PLACE OF BOARD OF ADJUSTMENT MEETINGS: The Bluffdale City Board of Adjustment shall hold one regular meeting on any Thursday of each month, as needed. The meetings shall be held at Bluffdale City Hall 14175 South Redwood Road, Bluffdale, Utah, which meetings shall begin promptly at 7:00 p.m. If the meeting date is a legal holiday, then the meeting is held at the same time and place above-described on the next following day which is not a legal holiday, Saturday or Sunday.

Section 4. This Ordinance shall take effect immediately upon passage and adoption by the City Council and subsequent publication or posting as required by law.
