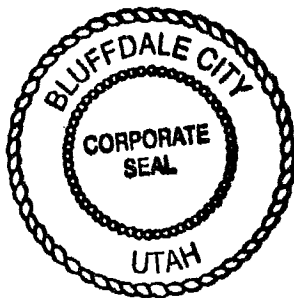

ORDINANCE NO. 2008-14

AN ORDINANCE RESCINDING ORDINANCE NO. 2008-11, ADOPTED JULY 22, 2008.

WHEREAS, on July 22, 2008, the City Council adopted Ordinance No. 2008-11, entitled “An Ordinance Adopting New Provisions Related to the Designation of Certain ‘Truck Routes’ and Prohibiting the Operation of Heavy Trucks Upon City Streets”; and

WHEREAS, the City Council deems it to be prudent and in the best interests of the City to rescind such Ordinance pursuant to this Ordinance; and

WHEREAS, the City Council desires to review the present condition of the City roadways, and to study the cause(s) of any damage and deterioration to such roadways.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF BLUFFDALE CITY, STATE OF UTAH AS FOLLOWS:

Section 1. Rescission. Ordinance. 2008-11 is hereby rescinded by the City Council in its entirety.

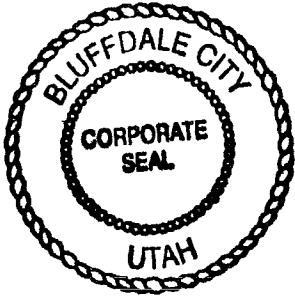
Section 2. Further inspection by City Engineer. The City Council hereby instructs the City Engineer to further investigate and inspect the condition and deterioration of the City roadways, and to study the cause(s) for any damage or deterioration of such roadways. Without limiting the generality of the foregoing, the City Council instructs the City Engineer to further consider the deterioration to the City roads, if any, caused by climatic conditions, and in connection therewith, to study whether the City roadways will be seriously damaged or destroyed unless certain vehicles are prohibited or vehicle weights are restricted. If the City Engineer determines that City roadways will be seriously damaged or destroyed unless certain vehicles are prohibited or vehicle weights are restricted, the City Council requests that the City Engineer make a recommendation to the City Council as to what types of vehicles should be prohibited, and/or what vehicle weights should be restricted.

Section 3. Severability. If any part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all provisions, clauses and words of this Ordinance shall be severable. This Section shall become effective without codification.

Section 4. Effective Date. This Ordinance shall take effect upon publication or posting, or thirty (30) days after passage, whichever occurs first.
