ORDINANCE NO. 2009-13

AN ORDINANCE AMENDING ORDINANCE 2009-03 REMOVING 3200 WEST (SOUTH OF 15000 SOUTH) AND 15000 SOUTH FROM THE LIST OF "AUTHORIZED TRUCK ROUTES."

WHEREAS, Bluffdale City has authority to regulate traffic within the corporate limits of the City; and

WHEREAS, the City Council is charged with the responsibility of providing for the protection and preservation of public resources and for the safety and good order of the community; and

WHEREAS, the Utah Department of Transportation has reopened Camp Williams/Redwood Road (State Route 68) after widening it to five lanes; and

WHEREAS there is a new more efficient road located at approximately 15800 South Camp Williams Road providing access to Camp Williams Road from property located in Herriman City to the west;

NOW, THEREFORE, the Bluffdale City Council ordains:

Section 1. Amendment. The Bluffdale City Council amends Section 9-6-101 of the Bluffdale Municipal Code as follows:

9-6-101 AUTHORIZED TRUCK ROUTES DESIGNATION AND ENFORCEMENT

...

(b) **Designated Restricted Vehicle Route.** It is unlawful for any person to operate or allow the operation of a restricted vehicle upon any public street within the City, except the following public streets, which are designated as the City's authorized truck routes:

- State Road 68 (Redwood Road / Camp Williams Road);
- State Road 154 (Bangerter Highway);
- State Road 140;
- Pony Express Road;
- Concord Park Drive;
- Honda Park Drive;
- Heritagecrest Way;
- ~~3200 West (south of 15000 South);~~
- ~~15000 South (between 3200 West and State Road 68);~~
- 790 West (north of 14600 South); and
- 800 West (south of 14600 South).

Section 2. Severability. If any part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all provisions, clauses and words of this Ordinance shall be severable. This Section shall become effective without codification.

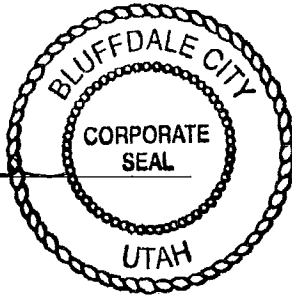
Section 3. Effective Date. This Ordinance shall take effect immediately upon publication or upon posting, whichever is earlier.
