A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLUFFDALE, UTAH, APPROVING THE "CONSOLIDATION OF POLLING LOCATIONS PLAN" REQUESTED BY THE SALT LAKE COUNTY CLERKS OFFICE, ELECTIONS DIVISION, TO CONSOLIDATE AND USE THE SAME POLLING PRECINCTS FOR BOTH MUNICIPAL AND COUNTY ELECTIONS.

WHEREAS, the City has contracted with the County Clerk's Office, Elections Division, to assist the City in conducting its 2005 Municipal elections; and

WHEREAS, the City desires to provide its citizens the opportunity to exercise their right to vote, and encourages voter participation by making the process as easy and accessible as possible; and

WHEREAS, the City desires to work together with the County Elections Division to manage voting precincts and identify polling locations for registered voters across Salt Lake County by Consolidation of all Polling Precinct locations for both Municipal and County elections;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BLUFFDALE CITY, STATE OF UTAH:



Section 2. Effective Date. This resolution will be effective immediately upon passage.

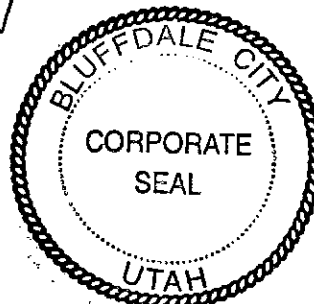


SL County has notified me that our Mayor and City Council members need to sign off on the established Polling Precincts (attached) for the 2005 Municipal Elections.



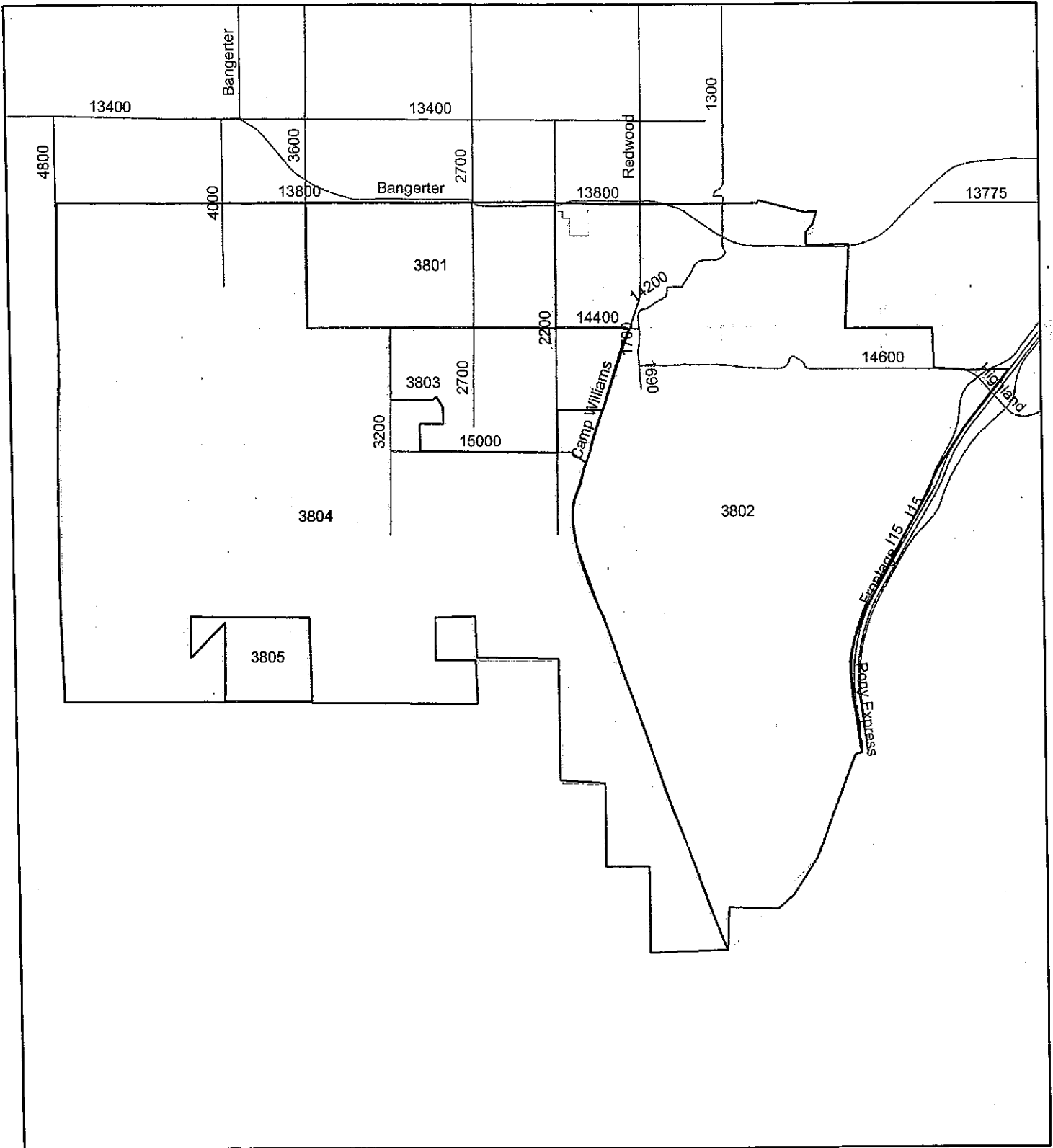
