Councilmember:	Bill Maxwell	Four-year term

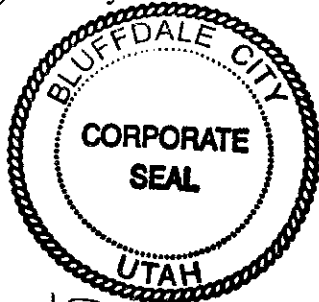
The City Recorder is authorized and directed to deliver a "Certificate of Election" to the said candidates.

Section 4. For purposes of Section 20A-4-304, Utah Code, the Certified Report of the Election Results when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Prepare and transmit a certificate of nomination or election under the officer's seal to each nominated or elected candidate;
- (iii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iv) File a copy of the certified report with the Lieutenant Governor.

Section 5. This Resolution Shall take effect immediately.

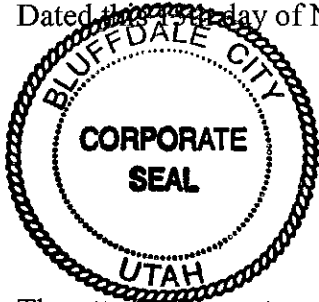


