

**BLUFFDALE CITY, UTAH**  
**RESOLUTION NO. 2006-25**

**A RESOLUTION DESIGNATING AND APPOINTING ELECTION JUDGES TO SERVE IN THE "BLUFFDALE CITY CITIZEN'S REFERENDUM ELECTION" JUNE 27, 2006; SETTING THE COMPENSTATION FOR THEIR SERVICES AND PROVIDING FOR OTHER RELATED MATTERS.**

**WHEREAS**, Section 20A-5-602, Utah State Code sets forth the procedure for appointing election judges, designation of their compensation and setting forth their duties; and

**WHEREAS**, the City Council of Bluffdale City, Utah desires to make election judge appointments, set their compensation and provide for other matters relating to them.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of Bluffdale City, Utah as follows:

**Section 1. Appointment of Election Judges.** The persons named as election judges on the list attached hereto are hereby appointed to serve in the "Bluffdale City Citizens' Referendum Election", June 27, 2006. The list contains the name, address, voting precinct and telephone number of all such persons appointed.


**Section 2. Availability of Election Judge List.** The list attached hereto shall be available in the City Recorder's office for inspection and examination during business hours by any voter of the City and any voter may make a copy of it.

**Section 3. Compensation.** The election judges shall receive \$130.00 each for supply judges and \$120.00 each for mainframe judges for each election day they actually serve, which will be June 27, 2006 for the "Bluffdale City Citizen's Referendum Election".


**Section 4. Certificate and Acceptance of Appointment.** The City Recorder is directed to issue to each election judge a certificate under the City Recorder's official seal certifying the appointment. A certificate of appointment shall be mailed to each judge and they have seven (7) days to sign the acceptance certificate and return it to the City Recorder.

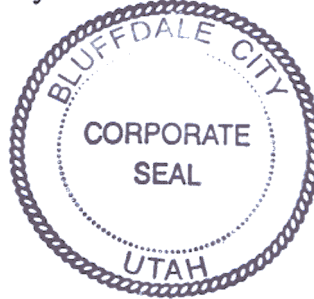
**Section 5. Oath of Each Judge.** The City Recorder shall administer an oath to each judge as provided in the Utah Sate Code.
