**A RESOLUTION APPROVING THE CANVASS OF THE
2006 BLUFFDALE CITY CITIZEN'S REFERENDUM ELECTION NUMBER 1**

Whereas, on June 27, 2006, the Bluffdale City Citizen's Referendum Election Number 1 was held; and

Whereas, on July 5, 2006 the City Council canvassed the returns of the said Bluffdale City Citizen's Referendum Election Number 1; and

Whereas, the City Council, during the canvass of the ballots, inspected the ballot results; and

Whereas, the City Council has determined that the election and voting were conducted in compliance with the law,

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF
BLUFFDALE, UTAH:**

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the report entitled "2006 Bluffdale City Citizen's Referendum Election Number 1 Certified Election Results" for the 2006 Bluffdale City Citizen's Referendum Number 1 held June 27, 2006.

Section 2. The Specific Development Plan chapter and zone is declared to have received the number of votes indicated:

FOR	424 VOTES
AGAINST	416 VOTES

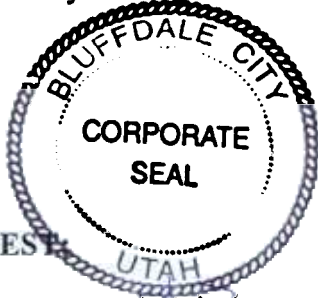
Section 3. The City Council, as the Board of Canvassers, declares the Specific Development chapter and zone to be in "full force and effect".

Section 4. For purposes of Section 20A-4-304, Utah Code, the Certified Report of the Election Results when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iii) File a copy of the certified report with the Lieutenant Governor.

Section 5. This Resolution Shall take effect immediately.
