

**BLUFFDALE CITY, UTAH
RESOLUTION NO. 2007-18**

**A RESOLUTION ESTABLISHING IMPROVEMENTS TO THE BLUFFDALE
CITY EQUESTRIAN AND EVENTS ARENA**

WHEREAS Bluffdale City has established the location of the Equestrian & Events Arena in the Bluffdale City Park at Approximately 14300 South and 2500 West; and

WHEREAS the arena area is established, used by citizens, and in need of improvements such as lights, sprinkler system and additional bleachers; and

WHEREAS it is anticipated that when the arena lights are installed, more groups will want to use the Equestrian & Events Arena in the evening hours; and

WHEREAS the Bluffdale City Parks and Recreation Department, desires to modify the fee schedule to help pay for the improvements.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
BLUFFDALE CITY, STATE OF UTAH, AS FOLLOWS:**

Section 1. Arena Improvements. The Arena may have permanent lights, sprinkler system and more bleachers added as to allow for more citizens and riding club usage during the evening hours, the arena improvements are to be determined as funds become available.

Section 2. Arena Usage. The Arena will be available for Bluffdale Town Days, celebrations, community and club events. The first reservation priority is granted to Bluffdale City or Department thereof, which plans and executes events for the citizens of Bluffdale. Second reservation priority is granted to the citizens, clubs and organizations that reside in Bluffdale, which has 60 percent Bluffdale residents participating in the organization. Third priority will go to outside citizens, clubs and organizations. Bluffdale City will have the right to reschedule any reservation that may conflict with Bluffdale City planned activities.

Section 3. Reservations. Reservations must be made in advance. Reservations may be made starting January, 2 of the calendar year of the intended use date/s. Reservations are first come, first serve.


Section 4. Severability. If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion

of this Resolution, and all section, parts and provisions of this Resolution shall be severable.

Section 5. Effective Date. This Resolution shall become effective upon publication or posting, or thirty (30) days after passage, whichever occurs first.
