

**RESOLUTION NO. 2007-20**

**A RESOLUTION AUTHORIZING EXECUTION AND IMPLEMENTATION OF AN ADDENDUM TO A BAILIFF SERVICES AGREEMENT BETWEEN BLUFFDALE CITY AND CONSTABLE BRINGHURST, LLC**

**WHEREAS**, Constable Bringhurst, LLC (“Bringhurst”) provides court bailiff services by contract to BLUFFDALE CITY (the “City”); and

**WHEREAS**, the City believes that it is in the best interest of the public to enhance the bailiff services provided by Bringhurst to have it include prisoner transportation services on behalf of the City; and

**WHEREAS**, Bringhurst agrees to provide the prisoner transportation services to the City by entering the Addendum to the Agreement for Court Bailiff Services with the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE BLUFFDALE CITY COUNCIL:**

**Section 1.** The Mayor is authorized to execute the Addendum to the Court Bailiff Services Agreement between Bluffdale City and Constable Bringhurst, LLC in the form attached hereto.

**Section 2.** The Mayor and other appropriate City officials are authorized to perform all acts they deem necessary and appropriate to implement the Agreement and all matters authorized in this Resolution.

**Section 3.** This Resolution shall become effective immediately upon passage. and authorizes and directs the Mayor to execute and cause to be delivered the same.

## ADDENDUM TO AGREEMENT FOR COURT BAILIFF SERVICES

This Addendum to the Agreement for Court Bailiff Services (the "Addendum") is made effective March 27, 2007, between **BLUFFDALE CITY**, a municipality of the State of Utah ("City"), and **CONSTABLE BRINGHURST, LLC**, a Utah limited liability company ("Constable"). The following additional terms are agreed upon between the City and the Constable and included in the Agreement for Court Bailiff Services:

### Additions and Modifications to Agreement:

**Section 1. Transportation Services.** Constable hereby agrees to provide transportation services for prisoners on behalf of the City at the following rates:

a. Fifty (\$50) dollars for transporting a prisoner from Bluffdale Justice Court to the Adult Detention Center ("ADC").

b. Fifty (\$50) dollars for transporting a prisoner from the ADC to Bluffdale Justice Court and back to the ADC (Roundtrip).

c. Fifty (\$50) dollars plus one (\$1) dollar per mile for transporting a prisoner from a facility outside of Salt Lake County to Bluffdale Justice Court and returning the prisoner to the facility outside of Salt Lake County, plus one dollar (\$1.00) per mile.

d. Twenty-five (\$25) dollars per hour, or fraction thereof billed at quarter of an hour increments, for wait time with prisoners at the court after the first hour for each prisoner.

Constable hereby represents and acknowledges that he is qualified to provide transportation services for the City as described herein and hereby agrees to perform such services competently, efficiently, professionally, and in accordance with applicable State law.


