

**BLUFFDALE CITY UTAH  
RESOLUTION NO. 2007-14**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLUFFDALE, UTAH,  
URGING THE UTAH LEGISLATURE TO NOT USE TOLLING AS A MEANS OF  
PAYING FOR CONSTRUCTION OR CORRIDOR PRESERVATION ALONG THE  
MOUNTAIN VIEW CORRIDOR.**

**WHEREAS**, the City recognizes the need for highway construction along the west side of the Salt Lake Valley; and

**WHEREAS**, the proposed route of the Mountain View Corridor would pass through the City of Bluffdale and be of use to the residents of the City of Bluffdale; and

**WHEREAS**, the City of Bluffdale strongly supports the construction of the Mountain View Corridor in care of local and regional traffic management and in support of economic development, the benefits of which will be realized throughout the state; and

**WHEREAS**, the Utah Department of Transportation has indicated a preference to use tolling as a means of paying for the construction of the Mountain View Corridor; and

**WHEREAS**, this would set a heretofore unseen precedent of tolling a public road in the State of Utah; and

**WHEREAS**, the financial estimates from the Utah Department of Transportation show that tolling will not cover the entire cost of the corridor preservation or construction of the Mountain View Corridor; and

**WHEREAS**, this would disproportionately shift the financial burden of constructing a necessary highway to only a portion of Salt Lake County; and

**WHEREAS**, there are multiple options available for paying for the construction and corridor preservation required to complete the Mountain View Corridor; and

**WHEREAS**, the City Council of the City of Bluffdale foresees the potential that tolling would create a disproportionate fiscal impact on the cost of goods and services for residents in Bluffdale; and

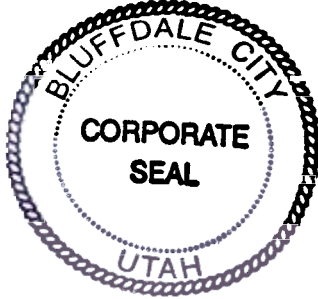
**WHEREAS**, the City Council of the City of Bluffdale finds it beneficial to make an official statement regarding the nature of these developments

**NOW, THEREFORE, BE IT RESOLVED BY THE BLUFFDALE CITY COUNCIL:**

**Section 1. Official Statement.** The City Council of the City of Bluffdale, Utah does hereby express and lend its full support to efforts to avoid the use of tolling along the Mountain View Corridor and encourages all members of the Utah Legislature and the Salt Lake County Council to oppose tolling along the Mountain View Corridor as well. Additionally, the City Council would encourage looking at all reasonable measures to support the funding and construction of this important transportation project.


**Section 2. Effective Date.** This Resolution shall become effective immediately upon its passage and authorizes and directs the Mayor to execute and cause to be delivered the same.
