**A RESOLUTION APPROVING THE CANVASS OF THE
2007 BLUFFDALE CITY REFERENDUM ELECTION NO. 1**

Whereas, on June 26, 2007, the Bluffdale City Citizen's referendum Election No. 1 was held; and

Whereas, on July 3, 2007, the City Council canvassed the returns of the said Bluffdale City Citizen's Referendum Election No. 1; and

Whereas, the City Council, during the canvass of the ballots, inspected the ballot results; and

Whereas, the City Council has determined that the election and voting were conducted in compliance with the law,

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF BLUFFDALE, UTAH:

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the report entitled "2007 Bluffdale City Citizen's Referendum Election No. 1 Results" for the 2007 Bluffdale City Citizen's Referendum Election No. 1 held June 26, 2007.

Section 2. Ordinance No. 2006-06, Ordinance No.2006-07, Ordinance No. 2006-08 and Ordinance No. 2006-09 creating the position of City Manager and transferring certain executive and administrative powers from the Mayor to the City Manager have received the number of votes indicated:

Section 3. The City Council, as the Board of Canvassers, declares Ordinance No. 2006 -06, Ordinance No. 2006-07, Ordinance No. 2006-08 and Ordinance No. 2006-09 to be in "full force and effect", with the caveat that Ordinance No. 2006-08 repeals and replaces Ordinance No. 2006-06 and Ordinance No. 2006-09 repeals and replaces Ordinance No. 2006-07.

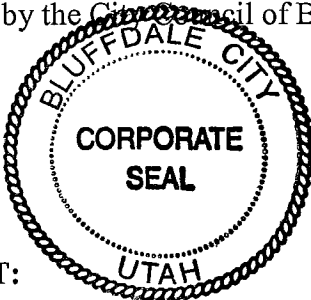
Section 4. For purposes of Section 20A-4-304, Utah Code, the Certified Report of the Election Results when signed by the election officer and by the members of

the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iii) File a copy of the certified report with the Lieutenant Governor.

Section 5. This Resolution Shall take effect immediately.
