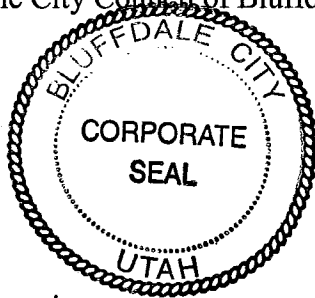
The City Recorder is authorized and directed to deliver a "Certificate of Nomination" to the said candidates.

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Prepare and transmit a certificate of nomination or election under the officer's seal to each nominated or elected candidate;
- (iii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iv) File a copy of the certified report with the Lieutenant Governor.

**Section 5.** This Resolution Shall take effect immediately.
