**A RESOLUTION APPROVING THE CANVASS OF THE
2007 BLUFFDALE CITY MUNICIPAL GENERAL ELECTION**

Whereas, on November 6, 2007, the regular Municipal General Election was held; and

Whereas, on November 27, 2007, the City Council canvassed the returns of the said Municipal General Election; and

Whereas, the City Council, during the canvass of the ballots, inspected the ballot results; and

Whereas, the City Council has determined that the election and voting were conducted in compliance with the law,

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF
BLUFFDALE, UTAH:**

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the report entitled "2007 Bluffdale City Municipal General Election Certified Election Results" for the 2007 Bluffdale City Municipal General Election held November 6, 2007.

Section 2. The following candidates are declared to have received the number of votes indicated:

Section 3. The City Council, as the Board of Canvassers, declares "elected" the following persons to the municipal office indicated:

Councilmember:	Bruce M. Kartchner	Four-year term

The City Recorder is authorized and directed to deliver a "Certificate of Election" to the said candidates.

Section 4. For purposes of Section 20A-4-304, Utah Code, the Certified Report of the Election Results when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Prepare and transmit a certificate of election or election under the officer's seal to each elected candidate;
- (iii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iv) File a copy of the certified report with the Lieutenant Governor.

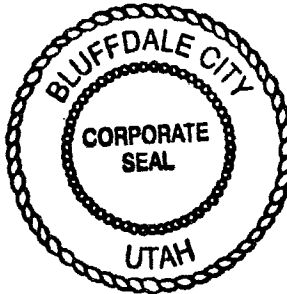
Section 5. This Resolution Shall take effect immediately.





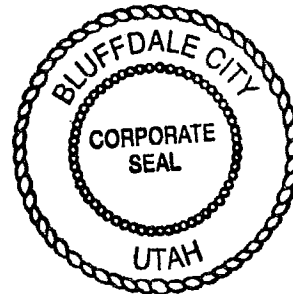
