

RESOLUTION NO. 2008-02

**A RESOLUTION APPROVING AN OPTION TO EXTEND THE RESIDENTIAL SOLID WASTE COLLECTION AND CURBSIDE RECYCLING SERVICE AGREEMENT BETWEEN THE CITY OF BLUFFDALE AND WASTE MANAGEMENT OF UTAH, INC.**

**WHEREAS**, the City and Waste Management of Utah, Inc. (Waste Management) have previously entered into a Residential Solid Waste Collection and Curbside Recycling Service Agreement, dated January 14, 2003; and

**WHEREAS**, the Bluffdale City Council has determined that it desires to continue providing such essential services and the current Agreement provides an option for extending services; and

**WHEREAS**, the Bluffdale City Council desires to extend the Agreement with Waste Management to provide certain solid waste collection and curbside recycling services for the City in accordance with the terms and conditions of the Agreement more particularly set forth herein;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BLUFFDALE CITY, STATE OF UTAH, AS FOLLOWS:**

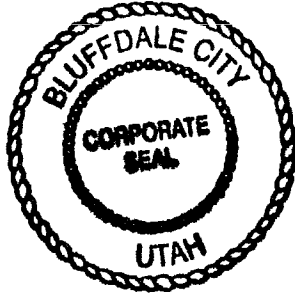
**Section 1. Extension Approved.** The Bluffdale City Council hereby approves the exercise of a two and one-half (21/2) year term extension of the City's contract with Waste Management, beginning January 1, 2008 and ending June 30, 2010, upon the terms and conditions agreed to between the parties, specifically concerning the modified service rates attached hereto as Exhibit "A" and incorporated herein by reference, and as otherwise set forth in the Agreement between the parties.

**Section 2. Modified Rates.** The service rates are hereby modified to reflect a 3% minimum increase or an increase tied to the 2007 CPI, whichever is greater, effective January 1, 2008. This increased rate shall be guaranteed through June 30, 2009. Following the guaranteed period, Waste Management shall be granted a 2% minimum rate increase or an increase tied to the 2008 CPI, whichever is greater, effective July 1, 2009.

**Section 3. Severability.** If any section, part or provision of this Resolution or its Exhibit "A" is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution or its Exhibit "A", and all sections, parts and provisions of this Resolution shall be severable.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its passage.
