Adopted by the City Council of Bluffdale, Utah, this 8th day of January, 2008.

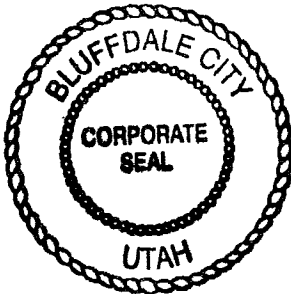
