Resolution No. 2008- 24

**A RESOLUTION OF THE BLUFFDALE CITY COUNCIL DECLARING ITS DESIRE FOR TRAIL CROSSINGS FOR PEDESTRIANS, EQUESTRIANS, AND WILDLIFE TO BE CONSTRUCTED ACROSS REDWOOD ROAD/CAMP WILLIAMS ROAD (SR-68).**

**WHEREAS** the City of Bluffdale (the "City") adopted a Trails Master Plan on August 28, 2007, pursuant to Ordinance No. 2007-24-A (attached as Exhibit A), to have certain trail crossings for pedestrians, equestrians, and wildlife across Redwood Road/Camp Williams Road (SR-68) as shown on the attached Trails Master Plan (*see* Exhibit A); and

**WHEREAS** the Utah Department of Transportation (UDOT) has begun a design-build project to widen SR-68 from Bangerter Highway to Saratoga Springs; and

**WHEREAS** the City believes it would be more efficient to plan for and construct the necessary trail crossings in conjunction with the SR-68 widening project; and

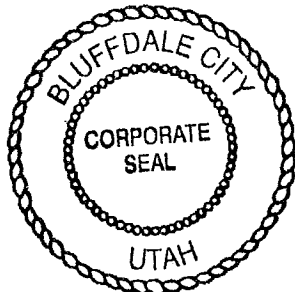
**WHEREAS** the City desires to reaffirm its intent that these crossings be in an integral part of the trail and transportation system in the City;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BLUFFDALE AS FOLLOWS:**


**Section 1. Reaffirmation of Intent and Desire for Trail Crossings of SR-68.** The Bluffdale City Council hereby reaffirms its intent and desire for the pedestrian, equestrian, and wildlife crossings as shown on the attached Trails Master Plan (*see* Exhibit A). The Bluffdale City Council declares these crossings to be an integral part of the trail and transportation system within Bluffdale City. The Bluffdale City Council also believes that it would be a more efficient use of public funds to plan for and construct these necessary trail crossings in conjunction with the SR-68 widening project and urges UDOT to accommodate and construct these crossings as part of the SR-68 widening project.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon passage.


