WHEREAS, the City desires to work together with the County Elections Division to manage voting precincts and identify polling locations for registered voters across Salt Lake County by Consolidation of Polling Precinct locations for Municipal elections;


Section 2. Effective Date. This resolution will be effective immediately upon passage.

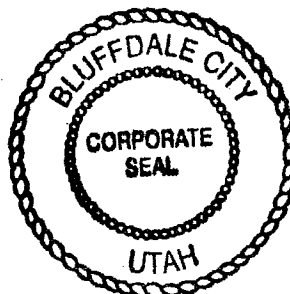

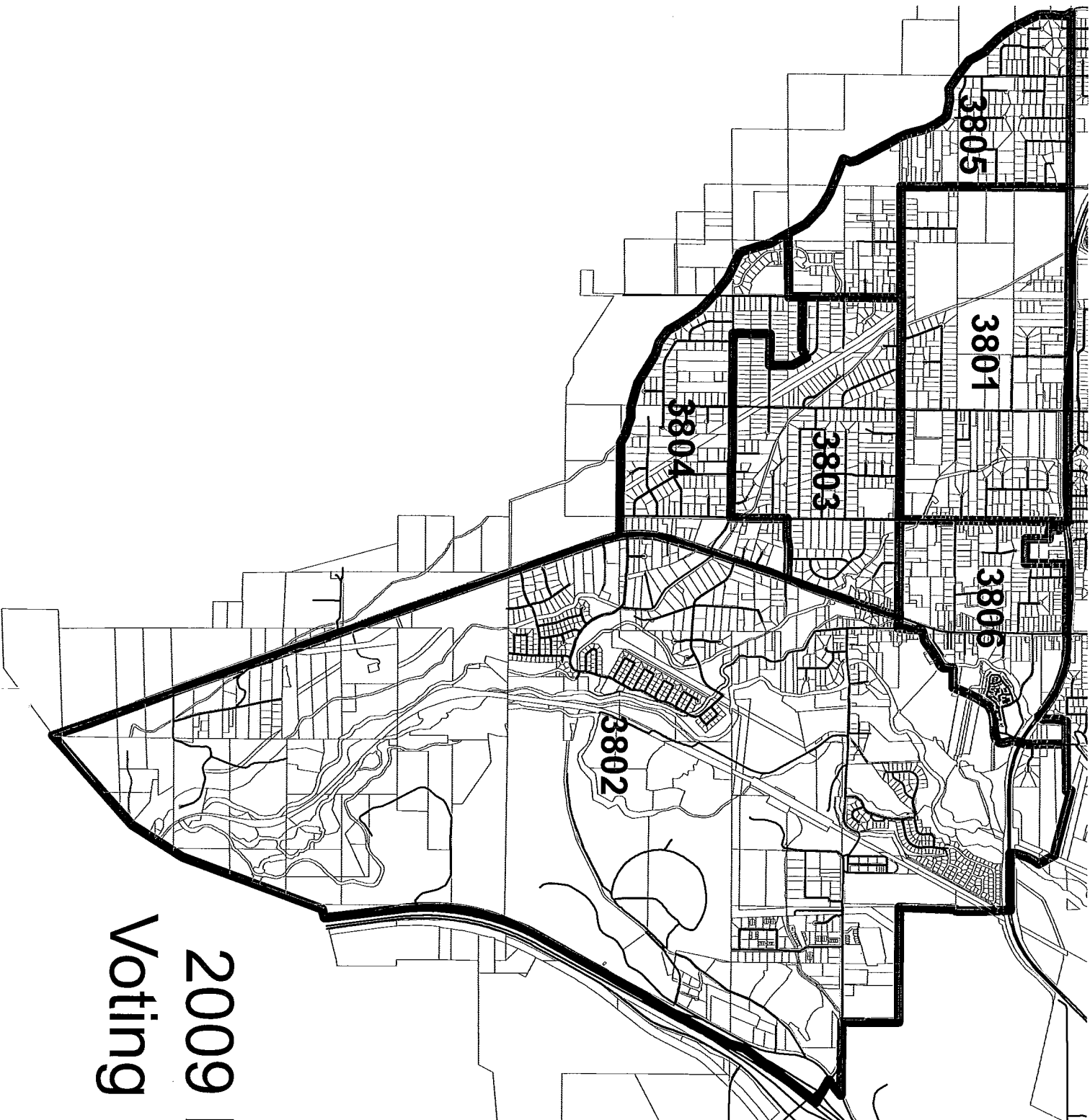
