

**CITY OF BLUFFDALE, UTAH**

**Resolution No. 2009- 20**

**A RESOLUTION OF THE BLUFFDALE CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE AN INSTRUMENT CONVEYING TO THE UTAH DEPARTMENT OF TRANSPORTATION A FEE SIMPLE PARCEL AND A TEMPORARY CONSTRUCTION EASEMENT FOR REDWOOD ROAD (SR-68) IN THE VICINITY OF THE BLUFFDALE CITY CEMETERY AT ABOUT 14205 SOUTH REDWOOD ROAD.**

**WHEREAS** the City of Bluffdale (the "City") owns property in the vicinity of 14205 South and Redwood Road (S.R. 68); and

**WHEREAS** the Utah Department of Transportation (UDOT) has begun a design-build project to widen SR-68 from Bangerter Highway to Saratoga Springs; and

**WHEREAS** the UDOT needs a fee simple parcel of 212 square feet and a temporary construction easement over approximately 267 square feet for the future right-of-way of Camp Williams Road; and

**WHEREAS** UDOT has offered \$2,725.00 as just compensation for the property interests to be acquired and other costs;


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BLUFFDALE AS FOLLOWS:**

**Section 1. Authorization to Execute a Temporary Construction Easement.** The Bluffdale City Council hereby authorizes the City Manager to execute an instrument conveying to UDOT a parcel of 212 square feet and a temporary construction easement over approximately 267 square feet in the vicinity of 14205 South and Redwood Road and other necessary documents for the Redwood Road right-of-way in consideration of Two Thousand Seven Hundred Twenty-five dollars (\$2,725.00) to be paid as just compensation for the fee simple parcel and temporary construction easement and other associated costs.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon passage.

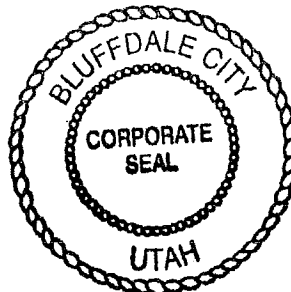
