**A RESOLUTION APPROVING THE CANVASS OF THE
2009 CITY OF BLUFFDALE MUNICIPAL PRIMARY ELECTION *RECOUNT***

Whereas, on September 15, 2009, the City of Bluffdale Municipal Primary Election was held; and

Whereas, on September 28, 2009, the Salt Lake County Clerks Office, Election Division conducted and supervised a *recount* of the Mayoral votes cast in said Municipal Primary Election; and

Whereas, on September 28, 2009, the City Council, as the Board of Canvassers of the election, canvassed the returns of said Municipal Primary Election *recount* and;

Whereas, the City Council, during the canvass of the ballots, inspected the ballot results; and

Whereas, the City Council has determined that the election and voting were conducted in compliance with the law,

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF BLUFFDALE, UTAH:

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the report entitled "2009 City of Bluffdale Municipal Primary Election Certified Election Results *Recount*" for the 2009 City of Bluffdale Municipal Primary Election held September 15, 2009.

Section 2. The following candidates are declared to have received the number of votes indicated:

Section 4. For purposes of Section 20A-4-304, Utah Code, the Certified Report of the Election Results when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Prepare and transmit a certificate of nomination or election under the officer's seal to each nominated or elected candidate;
- (iii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iv) File a copy of the certified report with the Lieutenant Governor.


Section 5. This Resolution shall take effect immediately.

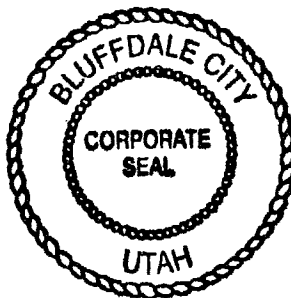

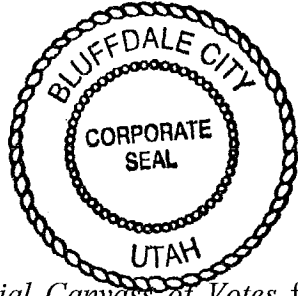
