ORDINANCE NO. 2005-11-A

AN ORDINANCE ADOPTING THE NEW TRAFFIC CODE PASSED BY THE UTAH STATE LEGISLATURE WITHIN THE CITY OF BLUFFDALE

WHEREAS, the Utah State Legislature adopted a new traffic code which became effective February 2, 2005;

WHEREAS, Bluffdale City desires to insure the health, safety, and welfare of the citizens of Bluffdale City; and

WHEREAS, Bluffdale City desires to comply with the recodified and revised State of Utah Traffic Code.

NOW, THEREFORE, the Bluffdale City Council resolves as follows:

Section 1 – Bluffdale City adopts the Utah Traffic Code as recodified and revised by S.B. 5 of the 2005 Utah Legislature.

Section 2 – The recodified and revised traffic code supercedes all previous traffic code adopted by Bluffdale.

This Ordinance shall take effect immediately upon passage.
